3. Make a presentation at the hosting industry networking session.

PLANNING MEETINGS



Purpose of the Weekly Industry Networking & Planning Meetings

1. To Establish Your \$24 Million Dollar Bubble
 - To determine who will be served through the Revolving Twenty-four Million Dollars: your general community, members, chapters, churches, teams or a specific industry.
2. To determine the specific project(s) to be funded and develop or critique the business-plan & budget.
3. To Setup your Funds and Merchant Account with the local participating bank.
4. To setup Your Video Podcast and Industry Networking Sessions on the Network (set communications strategy).
5. To identify the first 500 Small Businesses and nonprofits and invite them to your weekly Information Sessions (they are needed to purchase-with-you in-order to acquire the \$24 Million Dollars).
 - 50 users will be acquired and served first.
 - The 50 will each be required to influence 4 others to register = 200
 - The 200 will be served and required to register 2.5 others = 500
6. To meet the first 30 local Corporate Service-Providers.
 - Your group of 500 members will purchase specific products-from these companies.
 - To submit the purchasing contracts. The 30 corporations will each pay \$80,000 per million dollars for your guaranteed business.
 - Totaling \$2,400,000 per month for 12 months = \$28,800,000 (\$4 million paid to your organization for administration.
7. To train your administration team or set an administrative team to work with your organization.

The entire process electronically managed through the merchant services and the debit purchasing card. It is the electronic debit card that keeps all users and the corporations united and using one financial system.

The network's goal is to acquire 100 Administrators Across the Nation to Serve the Various Industries.
The System works best when 100's of communities are working this process simultaneously.

TO BE REMEMBERED ABOUT THE PROCESS

1. You are Marketing and Promoting Your own Agenda (not Wardell's or the Network's),
2. I or the network is not giving you money, we are setting-you-up and teaching you and your group how to acquire and keep the funds (meaning we are not giving you "the fish" "the money" we are teaching you how to fish how to get the funds and keep the funds revolving every year through your community or industry.
3. You are promoting and talking about What you are doing with the \$24 Million, Who it will Benefit, How it benefits them and how they can receive their share of this \$24 Million and their \$18k to \$120k.

REGISTRATION STEPS and ACCOUNT SETUP

\$300 Registration (payments available)

The \$300 is required due to the 80 hours worth of setup work, layout and data needed to establish your account and produce your services. Young adults perform all work and are paid. Your registration fee positions your organization and services so that individuals throughout the region and country will support and/or purchase from you. The \$300 is a small-major investment.

These steps also position your organization to be able to qualify for and accept all types of grants, funding, government and corporate contracts because you are now strategically partnered with 3500 organizations, media and small businesses etc. This fee is an investment and not a chance or gamble.

REGISTRATION STEPS:

- Fill out The Pre-Registration Form (online or in-person-print)
- Submit your two minute video or tv interview (come to studio to record or record on your own).
- Attend one of the __Monday Night or __Community Information Sessions (see schedule).
- Setup Your Online Account And PC Webpage (Media Centers will assist with setting up pages)
- Registration Packet, Certificate, Membership Card, Membership Badge.

YOUR \$300 REGISTRATION FEE PAYS FOR:

- Your Account and Web page-setup on the network and the mobile app.
- Your online services so that your 500 customers/supporters can access your services or products.
- The account positions your services & products in direct contact with the million plus users of your network/industry and are in-need of the services or products that you provide.
- The following will be added to your account: your bills, utilities, vendors, services, supplies, products and equipment that you need to operate your business or organization.
- Your television & radio Interviews and your appointment with your tv representative to discuss the media and marketing services that best fits your business or organization.
- Your \$10,000 Pitch Video & Presentation Production (produced by the Business Centers - you schedule your appointment).
- Your Business & Media Service Package. See list – to determine your need (your sessions at the business incubators with local professionals).

\$1,500 to \$10,000 PAY-OUT (Through the \$60 Million Dollar Group Purchasing Project)

- Your registration fee Pays for: Your deposit to open the Bank Account where your funds will be deposited.
- You Must Proceed to purchase from the companies in your network for 30 Days.
- You are not required to purchase any unplanned items or services. These are your everyday expenses. (Gas, food, supplies, equipment etc).
